

Asheville Montessori School Tuition Agreement 2022-2023

The financial stability of an independent school is essential to its overall success. Furthermore, independent schools must commit themselves to salaries, materials, insurance, etc. on an annual basis based on enrollment. Therefore, the absence or withdrawal of a student does not reduce operating expenses. These realities require us to ask for an annual commitment from our students.

Asheville Montessori School agrees to admit the child to the programs agreed upon on the Application Form. The undersigned agrees to pay the tuition and fees in accordance with the terms and conditions of the tuition schedule & policies attached hereto as Tuition Schedule (2022-2023).

Both parties agree the tuition is not refundable, regardless of non-attendance for any reason. Further, the undersigned agrees to give a minimum of 30 days notice in the event that their child is un-enrolled. Also, if a child is un-enrolled after **August 3, 2022**, and does not attend AMS, the parents/guardians will be responsible for the full August tuition.
